

**ARTICLES OF INCORPORATION
OF
DE LAVEAGA DISC GOLF CLUB
A CALIFORNIA PUBLIC BENEFIT CORPORATION**

ONE: The name of this corporation is DE LAVEAGA DISC GOLF CLUB.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are to promote the sport of disc golf; maintain the local disc golf course (mow the course regularly, collect and remove trash from the course, patrol the course, repair and replace course equipment, provide maps); provide free or low-cost recreational opportunities to residents of Santa Cruz and the surrounding region; provide a recreational outlet for local youth; serve as an information and referral network to public, private, and community recreational resources; provide regular free and low-cost opportunities for friendly, non-threatening competition; provide assistance with sports skills, in both a written format and a hands-on teaching format; provide a space for other local groups such as the Boy Scouts, Youth at Risk and other groups oriented toward helping disenfranchised youth; provide members from the De Laveaga Disc Golf Club to volunteer at the Special Olympics; help disabled young people participate in sports.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Marty Hapner, 132 Otis Street, Santa Cruz, CA 95060.

FOUR: (a) This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propoganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

SIX: The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
